In this short story, Edgar Allan Poe explores the meaning of black cats or the myth of black cats by drawing on American folktales in which black cats are associated with witchcraft. This tale has a gothic aesthetic in addition to a dreadful vibe. The setting of this short story is at night as a subtle nod to horror. The narrator speculates that since terror overtakes him every time, he might have gone insane. The cat, he was certain, was a spirit that had at last seized control of his thoughts. The narrator's beloved pet, a black cat he calls Pluto, morphs into a ghost for him.

At the last point of the story, when the police proceed to raze the wall where it is rumored that the narrator's wife's body lurks, an odd black cat reappears. Together with his wife, the narrator inadvertently buries it in the wall. He feared that the black cat had taken possession of him. The narrator adheres to Pluto has cursed him for his demise. The narrator also discovered that Pluto had renewed; however, since he remembered killing his black cat, which later materialized as the narrator's wife, he saw this as the labor of a witch or a ghost. His wife sounded to him like the cat he had assassinating, due to the consequences of the alcohol the narrator acquired, the curse brought about by the cat caused the narrator to become insane and lose control. In a nutshell the narrator senses that the black cat is a witch that has the ability to change into both his wife and his deceased pet black cat, Pluto.
